



01 名称：巴生中华总商会技职助学金
KLANG CHINESE CHAMBER OF COMMERCE & INDUSTRY (KCCCI) VOCATIONAL
SCHOLARSHIP.

02 宗旨：辅助家境清寒且品学兼优的学生完成技职学业。
Objective: To assist poor and needy student to further their Vocational Education.

03 资格：Qualification

(i)凡家境清寒，品学兼优的技职学生经本国技职教育录取者，均可提出申请。学生必须获得入学批准学院。

Applicants must be from poor and needy family with good academic result and characters

and has gained admission to local universities and colleges. For vocational studies, student must have gained admission to approval institutes.

(ii)

已经获得其他助学金者不得申请此技职教育助学金。一旦被发现，本会有权取消/收回已经发出的技职教育助学金。

Holders of any scholarship, bursary or loan are not allowed to apply. If discovered the chamber reserve the right to cancel or withdraw the Vocational Education Fund.

04 申请手续 : Procedure

(i) 凡欲申请本会助学金者，可向本会索取申请表格。

Applications forms can be obtained from the office of Klang Chinese Chamber of Commerce and Industry.

(ii)

申请人须填写表格，并附上照片一张（护照尺寸）、身份证复印本、STPM或统考文凭、学校成绩和该校录取证明书。

Completed application form must be accompanied with a passport size photo, photocopy of Identity Card, certified copy of SPM, STPM, Senior Middle III Unification Examination Certificate or equivalent, School Examination Result and Letter of Admission to vocational or college concerned.

(iii) 由1位介绍人（本会董事）推荐。

Recommendation of one introducer (KCCCI Council Member).

(iv) 受甄选之申请者，将由本会文教育组遴选委员会通知面试。

Short-listed applicants will be notified by the Selection Panel of KCCCI Culture & Education Sub-Committee to attend an interview.

(v) 本会教育组遴选委员会的决定将是最后的决定，申请者不能有任何的异议。

Decision of Selection panel of the KCCCI Education Sub-Committee is final. Any appeal from the applicants will not be entertained.

05 助学金金额：凡成功申请的技职学生可获得一次性3千令吉的助学金。

Amount of Bursary: Successful candidate will be awarded RM 3,000.00 per annum.

07 取消助学金:就读期间，若有犯罪或违反校规被校方开除、修读科目成绩不及格、中途辍学、神经失常、发现申请表格所填报之资料有不正确或未能如期毕业者，将停止其助学金。

Cancellation: If the holder of the education fund is dismissed by the relevant university / college due to the violation of rules, involvement of criminal activities, failing in the course, termination of course before graduation, mental disorder, discovery of fraudulent information given in the application form or unable to complete the course in time, the education fund will be withdrawn.
